Rules and Regulations of the Frankstown Township Memorial Park

- The roadway must remain open at all times in the event that an emergency vehicle is needed to access the two homes located beyond the park. Once the parking lots are full you must use the overflow parking lots located below the pavilions.**
- Park hours will be from 8:00 a.m. to dusk.
- No alcoholic beverages, gambling, smoking or illegal drugs are permitted on the park grounds or parking lots.
- No motorized vehicles are permitted on the park grounds.
- No bicycle riding is permitted in the park.
- No open fires are permitted in the park.
- Littering of any kind is unlawful. Please put garbage in receptacles provided.
- Vandalism and defacement of park property is unlawful and will be prosecuted.
Persons committing vandalism or theft will be responsible for all repair costs and restitution; and will be subject to other criminal penalties.
- Disorderly conduct will not be permitted.
- NO over-night parking or camping permitted.
- It is unlawful to discharge firearms, BB guns, air guns, arrows, sling-shots, or other type projectiles in the park and will NOT be permitted.
- No dogs or other pets permitted.
- Do not staple, nail or tack any item(s) to the Pavilion structure. Please remove any other forms of attachments, such as tape or strings, before leaving the pavilion.
- Renter Acknowledges that Franktown Township will not be present during the time that the renter uses the Memorial Park and the facilities therein and as such agrees to release the Township, it's agents, servants, employees, solicitor, and engineers from any claim that may arise during the use of the park and furthermore, renter agrees to indemnify and hold harmless Frankstown Township, it's agents, servants, employees, solicitor, and engineers from any and all claims that may arise in connection with the use of the Pavilion.
- Renter acknowledges that if any damage is done to Township property during the time period that renter is renting the pavilion; renter shall be personally liable for any and all said damages.
- Renter agrees to leave the premises and the pavilion in the same condition as when it was originally rented; meaning renter shall clean up the Pavilion after using the same.
